

## ARTICLES OF ORGANIZATION

OF

### RADIO 103, LLC

1. Name. The name of this limited liability company is Radio 103, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.
