**ARTICLES OF ORGANIZATION  
OF  
GRINGO WEDDING, LLC.**

The undersigned for the purpose of forming a Limited Liability Company, pursuant to Florida Statutes, Chapter 608, hereby files the following Articles of Organization.

**ARTICLE I: NAME**

The name of the Limited Liability Company shall be Gringo Wedding, LLC.

**ARTICLE II: PRINCIPAL OFFICE**
