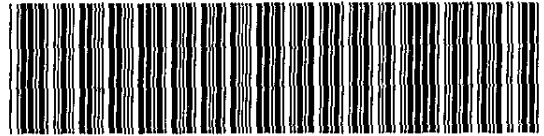

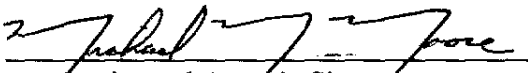

ARTICLE V – MEMBERS' RIGHT TO CONTINUE BUSINESS

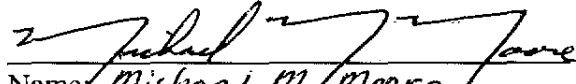
