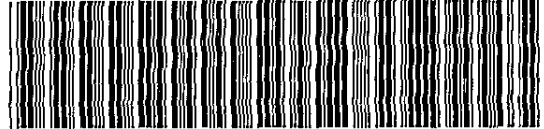

ARTICLES OF ORGANIZATION OF JLAJ, LLC


