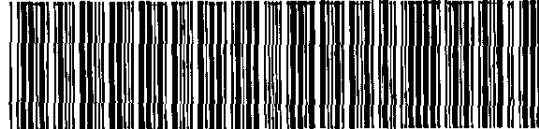

ARTICLES OF ORGANIZATION

FOUNDER:

Kyoshy Carlos H. Montalvo began his Martial Arts studies during his early middle school years in the City of San Sebastian, Puerto Rico. In 1969, he began his practice of Karate/Tae Kwon Do. Thereafter he practiced the Chinese style of Shaolin Tsu Kempo. Additionally, he practiced Boxing, followed by Okinawa Kempo Karate, where he received his First Degree Black Belt, followed by a Second.

In January 1974, both the Founder and his brother Miguel A. Montalvo, innagurated their first Okinawa Kempo Karate Dojo in San Sebastian, Puerto Rico. From 1974 to 1978, the Founder became the Inter-American University, San German Campus , Physical Education Professor / Coach, Martial Arts Trainer and Team Captain in Puerto Rico. By 1980, the Founder had established himself as one of the top Martial Arts fighters in the Caribbean.

In 1984, the Founder was tested to the ranks of 4th, 5th and 6th Degree Black Belt, by Grand Master Manny Saavedra, Founder of the World Sansei Goju Ryu Karate Organization. In 1995 the Founder received his 7th Degree Black Belt. In 1996 the Founder retired from active competition, carying with him an impresive attendance record in 372 Tournaments where he achieved in the top three positions , in 352 tournaments. In 2000 the Founder was promoted to 8th Degree Black Belt.

During his Martial Arts career, among other accolades the Founder, Kyoshi Carlos H. Montalvo:

In 2002, was inducted into the Florida Martial Arts Hall of Fame as "Florida Grand Master of the Year".

In 2002, was inducted into the Florida Black Belt Association Hall of Fame as " One of the Best Middle Weight Fighters in FBBA histoy".

In 2002, was inducted into the Hawaiian Martial Arts International Society Hall of Fame as " Grand Master of the Year ".

In 2000, was inducted into the International Ju Jitsu Hall of Fame, where he received the Federal Law Enforcement Instructor of the Year Award.

In 1995 he was inducted into the Latin American Martial Arts Hall of Fame, where he received a Life Achievement Award.

In 1994 was inducted into the World Martial Arts Hall of Fame where he received a Silver Life Achievement Award.

For his studies, endeavors and commitment, Founder Kyoshy Carlos H. Montalvo, has been internationally recognized as a pioneer and a legend in the Martial Arts.


