SECKLIART OF STATE AMENDED ARTICLES OF ORGANIZATIONAHASSEE, FLORIDA OF PROMPT TITLE SERVICES, LLC

The undersigned member(s)/manager(s), for the purpose of amending the Limited Liability Company of Prompt Title Services, LLC originally filed on June 1, 2005, under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of Limited Liability Companies adopt the following articles of organization:

ARTICLE I. NAME

The name of the limited liability company shall be: PROMPT TITLE SERVICES, LLC

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The street address of the limited liability company's principal office shall be: 5205 NW 65th Ave., Lauderhill, Florida 33319. The mailing address of the limited liability company's initial principal office shall be: 5205 NW 65th Ave., Lauderhill, Florida 33319.

ARTICLE III. EXERCISE OF POWERS

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of, the members of this limited liability company. This Article may be amended from time to time in the regulations of the limited liability company by a unanimous vote of the members of the limited liability company.

ARTICLE IV. MANAGEMENT

ARTICLE V. MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members by unanimous consent. Contributions required of the new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous written consent of the majority of members.

On death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.

ARTICLE VI. DURATION

The limited liability company shall exist until **December 31, 2060**, or until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.
