ARTICLES OF ORGANIZATION OF

JDC PROPERTIES OF FLORIDA/861EUBANKSCOURT, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be JDC Properties of Florida/861EubanksCourt, L.L.C. ("Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company shall be 900 Rathbone Avenue, Aurora, IL 60506.
