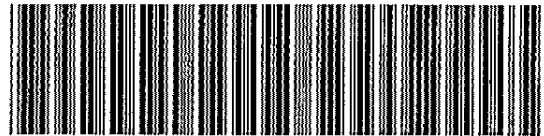

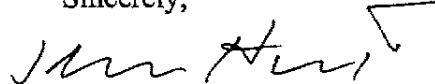

**ARTICLES OF ORGANIZATION
OF
Pine Vue Stables, LLC**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - NAME

The name of the limited liability company is Pine Vue Stables, LLC.

ARTICLE II - ADDRESS

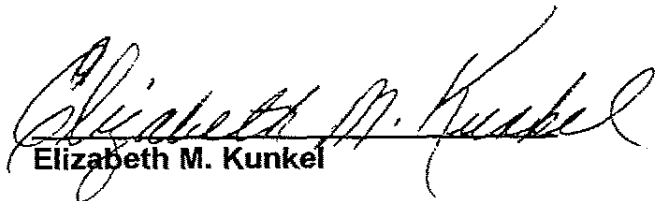
ARTICLE IX - OPERATING AGREEMENT

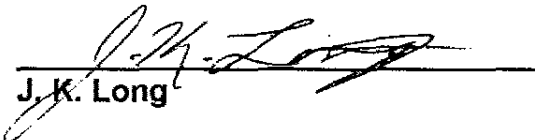
