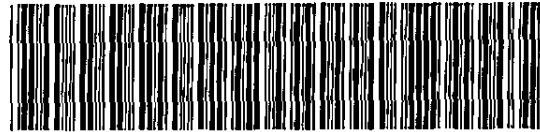

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, sets forth the following:

ARTICLE I

NAME

The name of the Limited Company is BRANDON USED CAR AUTOMALL, LLC.

ARTICLE II

PERIOD OF DURATION

The period of duration of the Limited Company shall commence five days prior to the filing of these Articles in the office of the Secretary of State of Florida and shall terminate upon the first to occur of the following:

- (i) December 31, 2055; or
- (ii) Dissolution of the Limited Company pursuant to provisions of the Florida Limited Company Act.

ARTICLE III

PURPOSE

The purpose for which the Limited Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Limited Company shall have all of the powers vested in a Limited Company organized and existing by virtue of such laws, including, but not limited to, the power to purchase goods.

ARTICLE IV

ARTICLE VI




