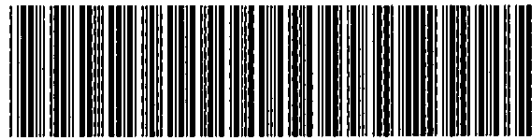



- FOURTH:: The following amendment to the Articles of Organization was adopted by the Company:


"ARTICLE I - NAME


