**ARTICLES OF ORGANIZATION
OF
PET-MAR HOLDINGS, L.L.C.**

The undersigned, desiring to form a Limited Liability Company under and pursuant to §608.405, Florida Statutes, does hereby certify as follows:

- FIRST: The name of said limited liability company shall be PET-MAR HOLDINGS, L.L.C.
- SECOND: PET-MAR HOLDINGS, L.L.C. shall exist in perpetuity.
- THIRD: Copies of the Operating Agreement of PET-MAR HOLDINGS, L.L.C. may be obtained from the Manager at 2655 LeJeune Road, Suite 1101, Coral Gables, FL 33134, which is the place in the State of Florida where the principal office of the limited liability company is located. The mailing address of PET-MAR HOLDINGS, L.L.C. shall be 2655 LeJeune Road, Suite 1101, Coral Gables, FL 33134.
- FOURTH: The purposes for which PET-MAR HOLDINGS, L.L.C. is formed are:




