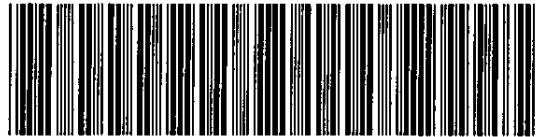


FIRST: The Articles of Organization were filed on JUNE 2, 2005 and assigned document number L05000054721.
