#### ARTICLES OF ORGANIZATION

#### A Florida Limited Liability Company

THE UNDERSIGNED, for the purpose of forming a limited liability company under Florida Limited Liability Company Act, adopts the following Article of Organization.

## ARTICLE ONE Name and Address

The name of the company is INVESCO REALTY, L.L.C., and the street address of the principle of the company and mailing address of the company shall be: 5162 N.E. 6<sup>th</sup> Avenue, #319, Ft. Lauderdale, Florida 33334.

#### ARTICLE TWO <u>Duration</u>
