Operating Agreement

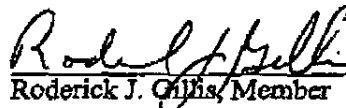

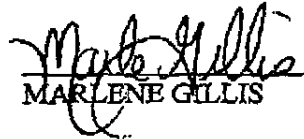
