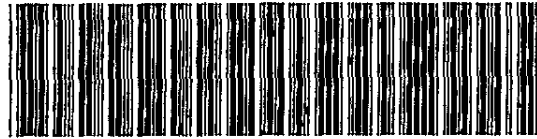



The name of the Limited Liability Company shall be OUTDOOR CONCEPTS OF ORANGE CITY, LLC.


ARTICLE II





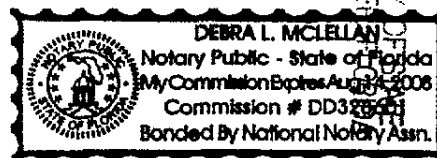
