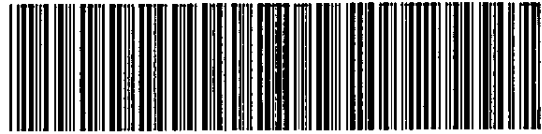

ARTICLE II


