FIRST: The date of filing of the Articles of Organization was June 6, 2005.

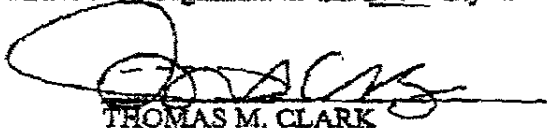
SECOND: The following amendment to the Articles of Organization was adopted by the limited liability company:
