The undersigned, being authorized to execute and file these Articles, hereby certifies that:

**ARTICLE I**

**NAME**

The name of this limited liability company is "SARACAR, LLC", referred to in these Articles of Organization as the "Company."

**ARTICLE II**

**PRINCIPAL OFFICE, MAILING ADDRESS AND  
REGISTERED AGENT**

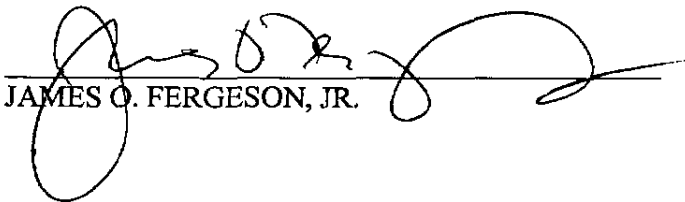
