ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION

SUNSHINE DIXIE INVESTMENTS, LLC

The undersigned, being the Manager of SUNSHINE DIXIE INVESTMENTS, LLC, a Florida limited liability company (the "Company"), hereby certifies that the Articles of Organization of the Company are modified and amended by these Articles of Amendment (the "Amendment"), as follows:

1. Article VIII of The Articles of Organization of the Company are hereby modified to provide that effective as of the date of this Amendment the named Managing Member shall be as set forth below:
