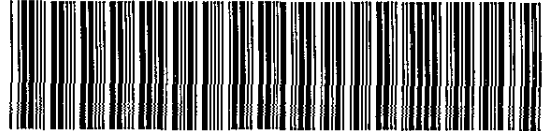


ARTICLE V
