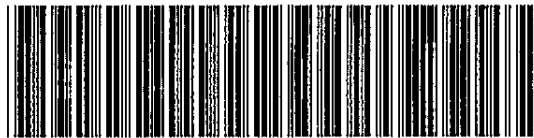

The undersigned, for the purpose of forming a single member limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and state the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be **PAT & CHUBBY, LLC** ("Company").

**ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the company shall be 2001 S. Ridgewood Avenue, Edgewater, Florida 32141.

**ARTICLE III -- DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual.

The company shall be dissolved on the death, bankruptcy, or dissolution of the member or on the occurrence of any other event that terminates the continued membership of the member in the company.

## ARTICLE IX -- MANAGEMENT

The company shall be managed by the member in accordance with regulations adopted by the member for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
