

The undersigned, for the purpose of forming a single member limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and The following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be PAT & CHUBBY, LLC ("Company").

These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
