

## ARTICLES OF ORGANIZATION OF OAKBROOK / ARGUS DEVELOPMENT, LLC

- 1. NAME. The name of this limited liability company is OAKBROOK / ARGUS DEVELOPMENT, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
- 2. PLACE OF BUSINESS. The mailing address and street address of the Company's principal office is 3825 Henderson Boulevard, Suite 101, Tampa, Florida 33629.
