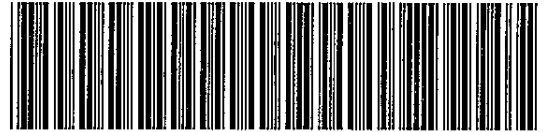

K & M DEVELOPMENT OF NORTH FLORIDA, LLC,
a Florida limited liability company

ARTICLE I

NAME

The name of this limited liability company is K & M DEVELOPMENT OF NORTH FLORIDA, LLC.


