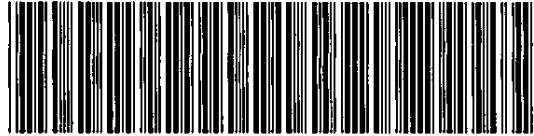

FOURTH: In accordance with Section 608.441, the Company was dissolved by written consent of all the members.


FIFTH: Pursuant to Section 608.4421, adequate provision has been made for the debts, obligations and liabilities of the Company.


SIXTH: There are no suits pending against the company in any court.
