ARTICLE I - NAME

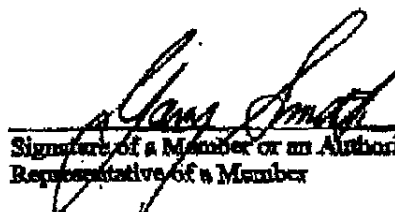
The name of this limited liability company is GLS Holdings, LLC (the "Company").

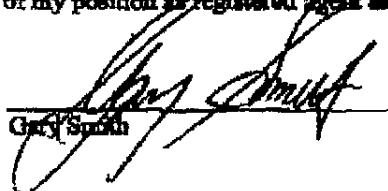
