4. JELR, LLC filed annual reports through and including April 29, 2014. Due to a misunderstanding without our accounting firm, JELR, LLC failed to file an annual report in 2015.

5. Unbeknownst to me, on January 5, 2016, two individuals, Jonason Coreus and Jean-Michel Leika, illegally filed a 2016 Florida Limited Liability Company Reinstatement. A copy of this 2016 Florida Limited Liability Company Reinstatement ("Reinstatement") is attached hereto as **Exhibit A**.

6. Neither myself nor Larry Rostkowski, the other member of JELR, LLC gave Mr. Coreus or Mr. Leika permission to file this Reinstatement. Neither Mr. Rostkowski nor myself know these individuals and we never approved of them filing the Reinstatement.



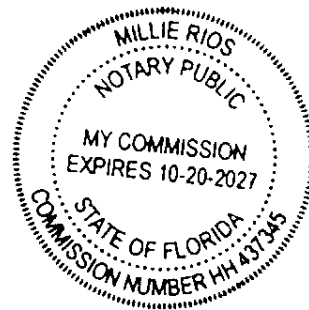
