ARTICLES OF ORGANIZATION

ARTICLE I - Name: The name of the Limited Liability Company shall be PBH PROPERTIES, LLC.

ARTICLE VIII- Applicable Regulations: If the Company does not have an Operating Agreement, as may be allowed under Florida Statutes, then the provisions of Chapter 608, Florida Statutes, or successor statutory provisions, will serve to govern

the operations of the Company.

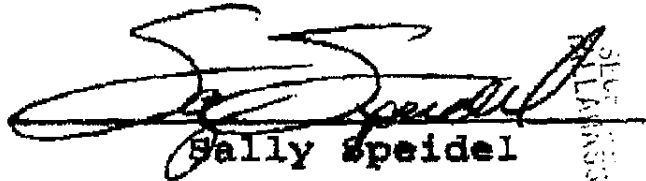
