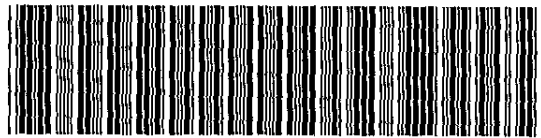

1. **Name.** The name of the limited liability company is MB Florida, LLC.
2. **Purpose.** The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.
3. **Address of Principle Office.** The address (mailing and street address) of the principal office of the limited liability company is 11 N. Summerlin Avenue, Suite 100, Orlando, Florida 32801.
