

ORDER ON PLAINTIFF'S MOTION FOR SUMMARY JUDGMENT
COUNT I DISSOLUTION OF MM97, LLC
AND APPOINTMENT OF RECEIVER COUNT II

THESE CAUSES, having come before the Court on May 17, 2013, upon the Plaintiff, KET, LLC's, Motion for Summary Judgment Count I Dissolution of MM97, LLC, and Motion for Appointment of Receiver Count II, and the Court, having reviewed the file and heard argument of counsel, and being otherwise fully advised of the premises, it is

ORDERED AND ADJUDGED as follows:

1. Plaintiff, KET, LLC's, Motion for Summary Judgment Count I Dissolution of MM97, LLC is hereby **GRANTED**. Plaintiff, KET, LLC's Motion for Appointment of Receiver Count II is hereby **GRANTED**.

2. No genuine issue of material fact exists; it has been established that the managers/members of MM97, LLC are deadlocked in the management of the limited liability company affairs, the members are unable to break the deadlock, and irreparable injury to the limited liability company is threatened or being suffered. Pursuant to Fla.

Stat. 608.4493, dissolution is appropriate.

3. MM97, LLC is hereby dissolved effective the date of this Order. The Clerk of the Court shall deliver a certified copy of this decree to the Department of State.

4. MM97, LLC is directed to wind up and liquidate the limited liability company's business and affairs in accordance with Fla. Stat. §608.4431 and notification of claimants in accordance with Fla. Stat. §608.4421.

5. MM97, LLC may no longer carry on business except that appropriate to wind up and liquidate its business and affairs, including:

- a. Collecting its assets;
- b. Disposing of its properties that will not be distributed in kind to its members;
- c. Discharging or making provision for discharging its liabilities;
- d. Distributing its assets in accordance with Fla. Stat. §608.444;
- e. Doing every other act necessary to wind up and liquidate its business and affairs.

6. The Court hereby appoints Joseph Miklas, Esquire as Receiver. In said capacity as Receiver, Mr. Miklas;

- a. May dispose of all or any part of the assets of the limited liability company wherever located, at a public or private sale, if authorized by the court.
- b. May sue and defend in the receiver's own name as receiver of the limited liability company in all courts of this state.
