## ARTICLES OF ORGANIZATION

OF

**CM WEST, LLC**

a Florida limited liability company

The undersigned, for the purpose of organizing a limited liability company pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Organization, and does hereby agree and certify as follows:

## ARTICLE I- NAME

The name of the limited liability company shall be **CM WEST, LLC** (the "Company").

## ARTICLE II- COMMENCEMENT OF EXISTENCE

This Company shall commence existence on the date these Articles of Organization are accepted and filed with the Florida Department of State and shall continue until terminated in accordance with the Operating Agreement of the Company.

## ARTICLE III- MAILING ADDRESS AND STREET ADDRESS OF PRINCIPAL OFFICE

The mailing address and the street address of the principal office of the Company shall be 5022 Southwest 91<sup>st</sup> Drive, Gainesville, Florida, 32608.

## ARTICLE IV- INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of the Company shall be located at 5022 Southwest 91<sup>st</sup> Drive, Gainesville, Florida, 32608 and the initial registered agent of the Company, at that address shall be Claudia West. The Company may change its registered agent or the location of its registered office, or both, from time to time without amendment to these Articles of Organization.

## ARTICLE V- PURPOSES AND GENERAL POWERS

The purpose for which the Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

## ARTICLE VI- ADMISSION OF ADDITIONAL MEMBERS

The Company shall admit additional Members only upon the unanimous approval of then existing Members.

## ARTICLE VII- MANAGEMENT

The management of the Company is reserved to its Members.

## ARTICLE IX- ADOPTION OF OPERATING AGREEMENT

The Company shall adopt an Operating Agreement for the Company, which may contain any provisions for the regulation and management of the business and affairs of the Company not inconsistent with these Articles of Organization, or Chapter 608 of the Florida Statutes.

## ARTICLE X- HEADINGS AND CAPTIONS

The headings or captions of these various Articles of Organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.
