**ARTICLE IV: MANAGEMENT**

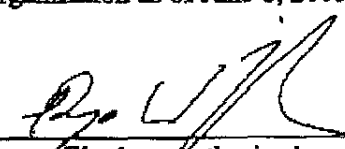
The limited liability company is to be a manager-managed company.
