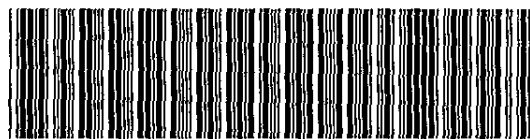

ARTICLES OF ORGANIZATION




