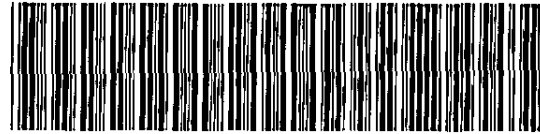


8. **Right to Continue Business:**


