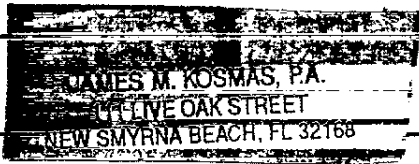

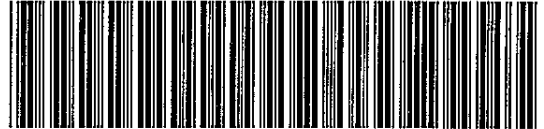

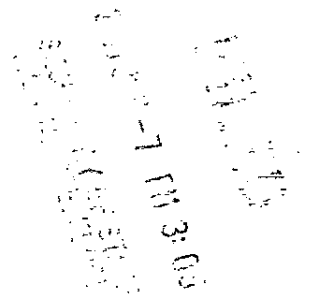

ARTICLE I - NAME

The name of this Limited Liability Company (the "Company") is CMHC-3 HOLDINGS L.L.C., a Florida Limited Liability Company.

pleasure of the Members, until the first annual meeting of the Members:



CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE


