#### ARTICLES OF ORGANIZATION

The undersigned persons, acting as the organizers of **STYLISTIC DESIGN DEVELOPERS AT TROUBLE CREEK**, **LLC**, (The "Company") under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopt the following Articles of Organization:

#### ARTICLE I. NAME AND ADDRESS

The name and address of the Company is: **STYLISTIC DESIGN DEVELOPERS AT TROUBLE CREEK, LLC,** located at 6151 Springer Drive, Port Richey, Florida 34668.

#### ARTICLE II. COMMENCEMENT AND DURATION OF EXISTENCE
