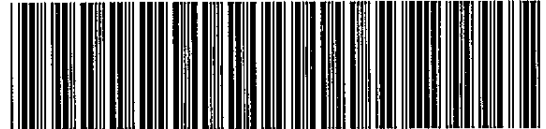

**ARTICLES OF ORGANIZATION
OF
J & M PIZZA LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes and files the following Articles of Organization.

ARTICLE I -- NAME

The mailing address and street address of the principal office of the Company shall be 6 Lyon Court, Newark, DE 19702.

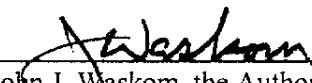
ARTICLE III -- REGISTERED OFFICE AND AGENT
