

ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I – NAME

The name of the Limited Liability Company is: **SORELLE ENTERTAINMENT LLC**

ARTICLE II – ADDRESS

The mailing address and the street address of the principal office of **SORELLE ENTERTAINMENT LLC** is 21510 Knighton Run Estero, Fl. 33928. The property where **Sorelle Entertainment LLC** will operate their business is **21510 Knighton Run Estero, FL 33928**.

ARTICLE III – DURATION


ARTICLE V – ADMISSION OF ADDITIONAL MEMBERS

Unless otherwise agreed to by the Initial Members, such members shall acquire no more than a total of thirty (30) percent of the membership interest in the LLC. ARTICLE VI – MEMBERS RIGHT TO CONTINUE BUSINESS

The right, if given, of the remaining members of the limited liability company to continue on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company shall be exercised in writing within one hundred eighty (180) days after such event. All the remaining members must give written consent to continue the LLC.
