

#### ARTICLES OF ORGANIZATION

#### H & M STORAGE, L.L.C.

The undersigned persons, acting as the organizers of **H & M STORAGE, L.L.C.**, (The "Company") under the Florida Limited Liability Company Act, Chapter 608, <u>Florida Statutes</u>, adopt the following Articles of Organization:

#### ARTICLE I. NAME AND ADDRESS

The name and address of the Company is: **H & M STORAGE**, **L.L.C.**, located at 5243 Hanff Lane, New Port Richey, Florida 34652.

#### ARTICLE II. COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the Company will commence upon filing, and the existence of the Company will continue perpetually.

#### **ARTICLE III. PURPOSE**

The Company may transact any or all lawful business for which a limited liability company may be organized under the Florida Limited Liability Company Act.

#### ARTICLE VII. MANAGEMENT OF COMPANY

The business of the Company shall be managed by the Manager who shall be elected annually by the members of the Company in a manner set forth in the regulations. The Manager shall have the power and authority to act on behalf of the Company as provided in the Florida Limited Liability Company Act, including, specifically, without limitation, Section 608.404, Section 608.404(1), and Section 608.425, and shall also hold the offices and have the responsibilities accorded by the members which are more particularly described in its regulations and any other Agreement that may be entered into between the members and the Manager. The Manager shall serve in that capacity until the first annual meeting of members or until a successor is elected and qualified.

#### ARTICLE VIII. REGULATIONS
