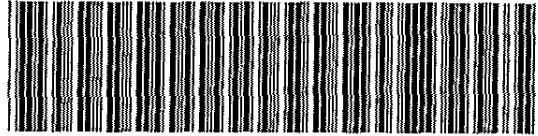

ARTICLE I

#### ARTICLE IV

The names and addresses of the Managing Members of R.F. BETTY MANAGEMENT, LLC are: Heather Robinson, 5 Heather Lane, Wilton, CT 06897 and Ira Friedman, 5 Heather Lane, Wilton, CT 06897. Future Managers of this Company shall be selected in the manner prescribed by the Operating Agreement of this Company and its authority is derived through such Agreement.

#### ARTICLE V

The names and addresses of the members and their ownership interest in this Company are:

- (A) HEATHER ROBINSON, 5 Heather Lane, Wilton, CT 06897, Fifty Percent (50%);
- (B) IRA FRIEDMAN, 5 Heather Lane, Wilton, CT 06897, Fifty Percent (50%).

#### Article VI

A Member's vote shall be per capita. If a membership interest is owned by two or more persons as tenants in common, tenants by the entirety or joint tenants with rights of survivorship, one vote is allocated equally between all persons holding a membership interest in such manner.

#### Article VII

The death or adjudication of incapacity of an Owner or assignment of a Member's interest will not dissolve this Company. An assignment of a Member's interest may not be made unless a majority of the non-assigning members approve of such assignment. An assignee of a membership interest may only become a Member upon written approval of all the Members. The adjudication of incapacity

or change of ownership because of death of an owner shall not be considered as an assignment.

#### Article VIII

This Company is organized for the purpose of real property investments, including but not limited to the purchase and sale of real property and conveyance of title to real property by deed, being the mortgagor and mortgagee on mortgages and the maker and payee on notes, entering into and becoming both the lessor and lessee on leases, collecting and paying rent, subdividing real property, and any other purpose not prohibited by the laws of the State of Florida and the United States and any other state or sovereign country where real property in which this Company has an interest is located.

#### ARTICLE IX

These Articles of Organization may be amended or revoked by a three-fourth(3/4th) vote of the Members of this Company.

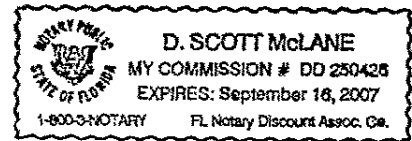
