

ARTICLES OF ORGANIZATION FOR

ADJ & ASSOCIATES, LLC



The undersigned member hereby certifies to the following in order to form a Limited Liability Company under Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of the Limited Liability Company is ADJ & ASSOCIATES, LLC.

ARTICLE II - DURATION
