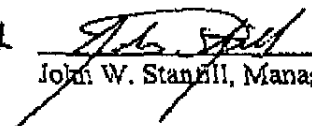

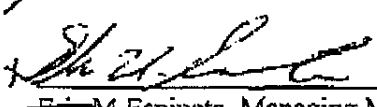
**Article V - Member Interest transfer restrictions**
