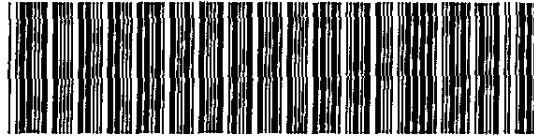

The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be:


No additional members shall be admitted to the company except with the unanimous written consent of all the members of the


