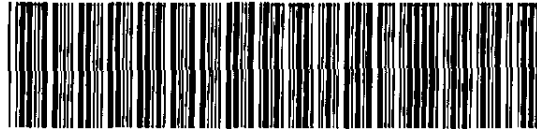

1. **ARTICLES OF ORGANIZATION.**

**ARTICLE I
NAME**

The name of the Limited Liability Company is as follows:

VERO BEACH BUS SALES, L.L.C.

**ARTICLE II
ADDRESS**

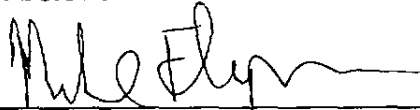
ARTICLE VIII

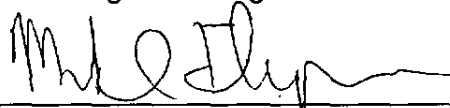
