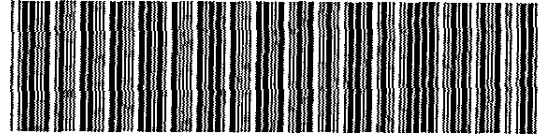

## **ARTICLE VI. MANAGEMENT.**

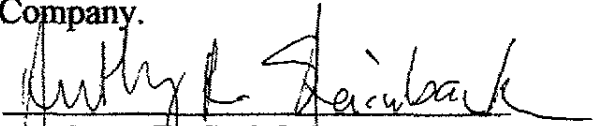

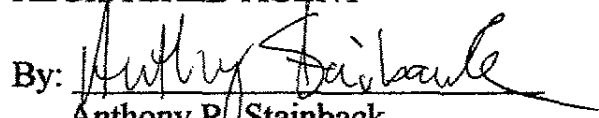
