# AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF FAMCO HOUSING GROUP, LLC f/k/a SINASE, LLC (Document # L05000060501)

The Articles of Organization of Sinase, LLC (the "Company") were filed on June 17, 2005. In accordance with Section 608.411, these Amended and Restated Articles of Organization of Sinase, LLC have been duly executed and arc being filed to amend and restate in their entirety all prior articles of organization filed on behalf of the Company. The Company's Amended and Restated Articles of Organization are as follows:

## ARTICLE I

7006 JUN - 1
