

ARTICLES OF ORGANIZATION

OF

JPG HARBOR SHOPS LLC



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I NAME

The name of the limited liability Company shall be JPG HARBOR SHOPS LLC ("Company").

ARTICLE II ADDRESS
