SECOND: The Articles of Organization were filed by the Company on June 20, 2005 and assigned document number L05000060924.

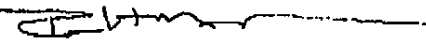
THIRD: The following amendment to the Articles of Organization has been adopted by the Company:
