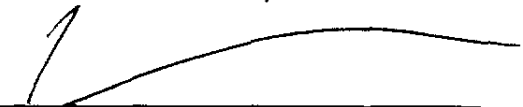

This limited liability company is to be initially managed by JOHN S. COPANOS, until he is removed or it resigns and its successor or successors are elected.

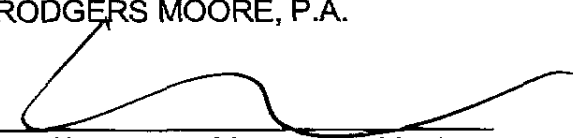

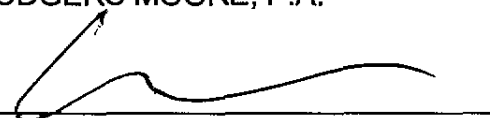
