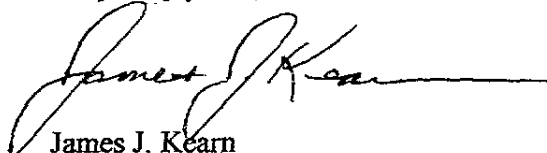

**ARTICLES OF ORGANIZATION
OF
RAIMAC, LLC
A LIMITED LIABILITY COMPANY**

The undersigned, for the purposes of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and the following Articles of Organization.

ARTICLE I - NAME

affirmation under the penalties of perjury that the facts stated herein are true.

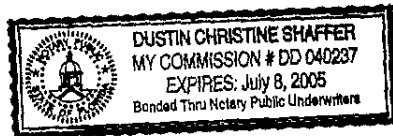
